

# **Travel Agreement**

## **Plein Air Painting Adventure in Italy with Kathleen Speranza October 13-23, 2019**

This agreement sets out what Winslow Art Center, LLC (“WAC”) agrees to provide during the workshop and what you agree to do in return. Each participant should print, fill out, sign, and return the agreement in full to WAC with the \$600 non-refundable deposit to reserve their place. A separate signed agreement with deposit must be provided for each participant.

## **Cost Per Person:**

**Painting course participants: \$3850 US.**

**Non-painting guest in shared room with workshop participant: \$3150.**

## **Included**

Rendezvous in Rome, October 13 and shuttle from there to Castello di Petroia. Those participants not arriving in Rome will make their own arrangements to arrive October 13. Trip ends October 23 with drop-off in Rome.

- 10 nights at the Castello di Petroia. Prices are based on single occupancy with ensuite bathroom. Suite upgrade available
- Sumptuous meals at the castle's Restaurant  
Accomanducci: All breakfasts, 8 lunches & 10 dinners, including wine (Special dietary restrictions can be accommodated)

- 9 full days of painting and art immersion with Kathleen Speranza
- Day excursion to Gubbio
- Olive oil tasting
- Wifi
- Plenty to do for non-painting partners

**Not Included:**

- Airfare/Travel insurance (strongly recommended)
- Painting supplies
- Cooking lessons/truffle hunting may be arranged (additional fee)
- Independent meals, independent sight-seeing, personal expenses
- Gratuities
- **Additional Terms**
  - \$600 non-refundable deposit per person due upon registration. Final payment is due no later than May 15, 2019. Missing the final payment deadline

may result in your being removed from the workshop, especially if a waiting list has formed!

- Travel insurance strongly recommended
- Itineraries are subject to change. Italy is full of surprises and we need to be flexible enough to take advantage of whatever comes along to provide you with the best possible travel experience. Activities in the itinerary may be substituted for alternative experiences, should the need arise.

## **Payment Details**

Registering for the workshop requires a \$600 non-refundable deposit payable by check, or credit card. The remaining balance due must be paid by check or bank transfer no later than 90 days prior to the start of the workshop. If you wish to pay the remaining balance by credit card there will be a 3.75% fee applied to cover the costs. Please note, WAC reserves the right to treat your reservation as canceled if your final payment is not made when due. If you sign up for a trip 90 days or less before the departure date, the entire trip price is due – payable by check, bank transfer, or credit card with 3.75% additional charge applied.

## **Workshop Cancellation Policy**

All fees paid (minus deposit) are refundable up to 90 days before start of event, *IF* the retreat sells out *AND* we/you find someone to take your spot.

Injury or illness are not exceptions to the above terms. This is why we highly recommend that you purchase travel insurance. (please see below for more information.)

If you pre-registered to hold your space, your balance must be paid in full 90 days before the start of the workshop. All registrations received within 90 days of the workshop start date must be paid in full at the time of registration.

Please do not ask WAC to make exceptions to our refund policy. We make decisions based on you signing up in the first place: we book guides, reserve vehicles and hotel rooms, and pre-pay activities, most (or all) of which costs are not refundable to WAC. Our workshops are often full and a cancellation often means we have lost the opportunity to give your spot to someone else. Remember you have the option to get travel insurance and if you choose not to purchase this, you are taking a risk.

If WAC elects to cancel the workshop, the entire amount you have paid to WAC will be refunded to you within 14 days after the tour's cancellation. In the unlikely event this should occur, WAC has no other obligations to tour participants for cancelled trips including costs or fees related to the issuance and/or cancellation of airline tickets or other travel reservations not made by WAC. WAC has no responsibility to provide refunds if the workshop is cancelled as the result of risk or threat of war, riot, civil strife, industrial dispute, terrorist activity, natural disaster, fire or other similar events beyond WAC's control. In the event the designated art instructor is unable to instruct the workshop, WAC may, at its sole discretion, substitute a qualified instructor to teach the course, or cancel the trip, in which case WAC will refund amounts paid by tour participants to the WAC as provided above.

### **Insurance Information:**

WAC does not offer travel insurance and will not be responsible for reimbursement of any costs, payments or damages incurred by tour participants except as specifically provided in this agreement. Personal travel insurance is, therefore, strongly suggested to cover non-refundable costs such as airline tickets, loss of

luggage, trip delays, medical evacuation, foreign medical coverage, and reimbursement of accommodations, workshop tuition and other tour costs.
